For its mobility services XXImo charges the following rates per XXImo Mobility Card.

The above rates are exclusive of VAT, valid until 31 December 2019. Each mobility service is separate from each other, per card holder, to authorize from the XXImo-self-service website.

The monthly basic fee (€ 2.95 per month per cardholder) will be charged six months in advance. Any additional mobility services and/or mutations will be charged directly per month and specified on the invoice.

With the XXImo declaration module loose declarations can be claimed, if a card holder was unlikely not able to pay with the XXImo Mobility Card. The costs are € 2.50 per declaration. When one has declared because of a failure of XXImo, these costs will not be charged and the card holder receives € 2.50 extra in return for the inconvenience.
